Media, Migration and the Rise of Nationalism Comparing European and Asian Experiences and Perspectives

Call for Paper/Presentation for the Training Seminar of Master/PhD Course Students

Ph. D. Koen Leurs (Assistant Professor, Department of Media and Culture Studies, Utrecht University, the Netherlands) and I (Tomohisa Hirata, Associate Professor, Faculty of Social and Information Studies, Gunma University, Japan) are organizing JSPS-NWO Joint, Bilateral Seminar titled "Media, Migration and the Rise of Nationalism: Comparing European and Asian Experiences and Perspectives". This Seminar will be held from 19th to 21st Sep. 2018, at 3331 Arts Chiyoda (Chiyoda-ku, Tokyo, URL: http://www.3331.jp/).

At the first day of this seminar (19th Sep.), we will open the training seminar for master course/Ph. D. talented students who have conducted research on the theme of the seminar and other related fields. We will also provide these students an opportunity to give presentations in English and to exchange opinions with peers and middle/senior-career researchers.

We are looking forward to hearing from a lot of applicants who are trying to examine this challenging theme through various methods of academic research.

- 1. Eligibility for applicants: Master course/Ph.D. students in Japanese universities/research institutions.
 - *Those who have already had Ph.D. are not eligible, however, the organizers welcome applicants who are from any nation if they belong to Japanese universities/research institutions
- 2. Topics: Related to media, migration and nationalism
 - *The organizers suppose applicants who major media & communication studies, gender studies, migration studies, (human) geography, sociology, anthropology and related academic fields

- 3. Number of Presentations: Maximum 3 presentations (from Japan)
- 4. Application form: An English application form is available.

 - *Organizers will send all applicants the result of screening by 11th May 2018 via e-mail.
- 6. Grants: The organizers will arrange hotel accommodation for presenters from the 18th to 21st of September maximum (check-out on 22nd Sep.). A round-trip ticket from the nearest station of the university/institution to which the presenter belongs to the hotel which is around 3331 Arts Chiyoda and an excursion fee (on 22nd Sep.) will be covered by JSPS fund. We will also provide the presenters the lunch fees to join the lunch meetings in this seminar (from 19th to 21st Sep.) to exchange their opinions and build academic linkages.

The purposes of JSPS-NWO joint, bilateral seminar Media, Migration and the Rise of Nationalism

- 1) The bilateral seminar seeks to move beyond the Euro-American focus in the study of media and migration studies. The predominant scholarly in studies on migration and nationalism focus on experiences and perspectives in the North-American and European Context. How can we re-conceptualize our understanding of the role of media in migration and nationalism drawing from situated contexts in Japan, and countries like China, Vietnam, Laos, Myanmar and the Philippines in the context of East and South-East Asia?
- 2) The seminar seeks to explore what Japan (East Asia) and Southeast Asia can learn from the partly overlapping and partly diverging context of migration and the rise of nationalism in the Netherlands and Europe, and vice versa. The focus is on the contradictory role technologies play in migration management, control, integration and community formation, transnational communication but also conflict and extremism. The seminar is highly interdisciplinary, invited speakers come from disciplines including media, communication, gender, migration, geography, sociology and anthropology. The organizers seek to disseminate findings by publishing an open access journal special issue in Comparative Migration Studies, by offering policy recommendations as well as by distributing artistic impressions of main debates and findings.
- 3). The seminar is designed to exchange scholarship but a strong training component is central to our aims. For this purpose, one day of masterclasses is dedicated to training a selection of 3 talented students (MA/PhD level) from Japan (and 3 students from the Netherlands). Furthermore, alongside inviting a core group of established senior scholars, we are balancing the program to ensure the participation of young emerging scholars.
